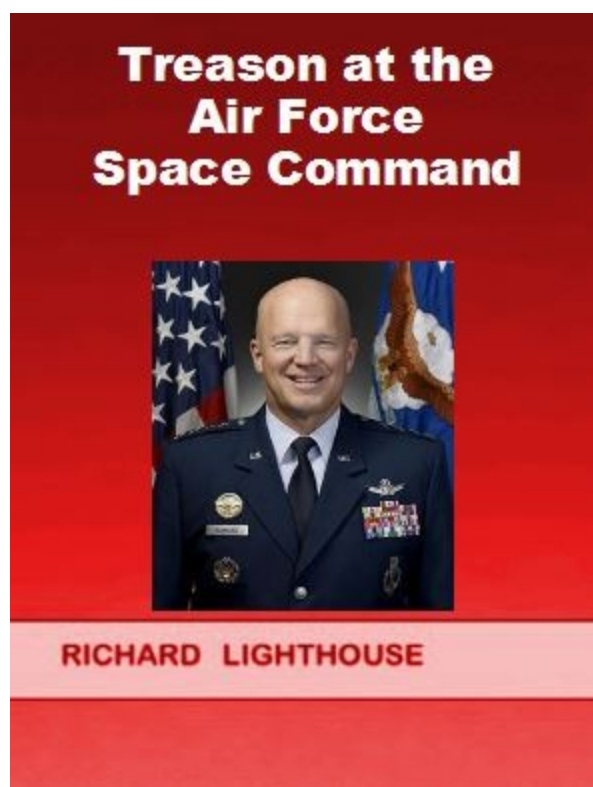

Abstract

Rev 2C - This short ebook provides the author's opinions and accuses 12 military officers of High Treason against the United States (The Dirty Dozen). The Air Force Space Command, headquartered in Colorado Springs, Colorado, is the primary organization that is using microwave satellite technology to track and attack civilians all around the world. These civilians are known as Targeted Individuals. Many of these civilians are political activists and whistleblowers – people that the Deep State would like to silence. The family relationships of Targeted Individuals have been destroyed through the use of subliminal messaging. Their careers, and finances can be ruined. Introduction

The Air Force Space Command has about 38,000 employees, based at many locations, and

has its headquarters in Colorado Springs at Peterson Air Force Base. As previously noted in my ebooks, the satellite tracking frequencies have been scientifically measured at 3600 MHz - 3750 MHz, and the attack frequencies are 3920 MHz – 3935 MHz. 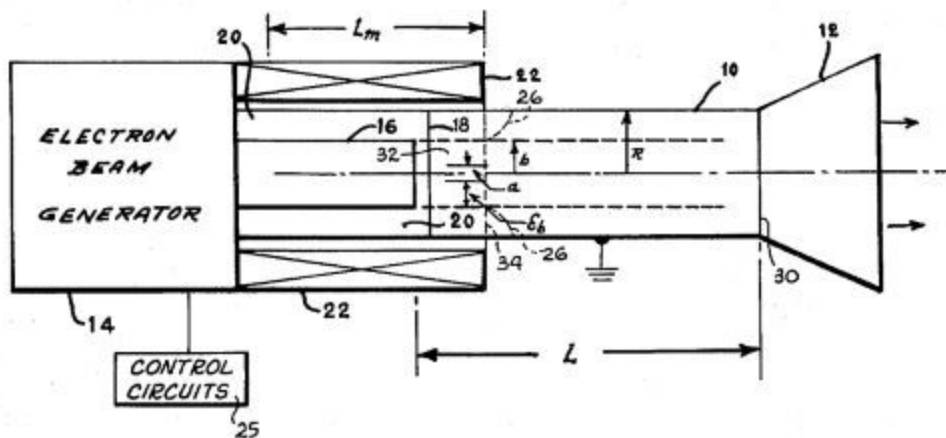


Figure 3. Vircator - Microwave satellite weapon. From U.S. Patent 4345220

There are 4 active-duty squadrons within the 50th Operations Group, under the Air Force Space Command. According to the LinkedIn Profile of Charles Shurchay (Superintendent - Air Force Space Commoand) there are 1,300 personnel, 7 DoD Satellite constellations, and 9 weapon systems that are operated under the 50th Operations Group. Clearly, these are not simply communications satellites.

Many of these satellites are positioned in geosynchronous orbit, and are part of a network that includes communications, tracking, and attack satellites. Using the precise GPS coordinates of any Targeted Individual, the coordinates can be transferred to local cell towers or UAV drones for additional targeting. The GPS coordinates are accurate to +/- 0.5 centimeters or better, which allows different body parts to be targeted and attacked in a grisly, daily ordeal.

U.S. Air Force - Tracking Everything in Earth Orbit

Keep in mind that the U.S. Air Force has responsibility for tracking all objects in earth orbit, through many joint organizations – which means if they are not the organization responsible for targeting civilians, then they certainly know who is. If they deny it, perhaps the Air Force would like to tell us, who is responsible for the microwave satellites?

NORAD and NORTHCOM are responsible for tracking all aerial and orbital objects that may be a threat to the United States. They have headquarters located on Peterson Air Force Base. “USSTRATCOM's (*part of the Air Force budget*) space control mission includes: surveillance of space, protection of U.S. and friendly space systems, prevention of an adversary's ability to use space systems and services for purposes hostile to US national security interests, and direct support to battle management, command, control, communications, and intelligence. The space control mission is conducted by USSTRATCOM's Joint Functional Component Command for Space (JFCC Space).

JFCC Space, through its Joint Space Operations Center (JSpOC), detects, tracks, and identifies all artificial objects in Earth orbit. The JSpOC is a synergistic command and control weapon system focused on planning and executing USSTRATCOM's JFCC Space mission. Its purpose is to provide a focal point for the operational employment of worldwide joint space forces, and enable the Commander, JFCC Space (CDR JFCC SPACE) to integrate space power into global military operations.

The JSpOC is composed of six core divisions: Strategy Division (SRD), Space Surveillance Division (SSD), Combat Operations Division (COD), United Space Vault (USV), Intelligence, Surveillance and Reconnaissance Division (ISR), and Operations Support Division (OSD). “

Peterson hosts 53 tenant units including Air Force Space Command, NORAD/U.S. Northern Command, U.S. Army Space and Missile Defense Command/U.S. Army Forces Strategic Command, and the 302nd Airlift Wing.

Peterson AFB has an annual estimated economic impact of \$1.3 billion (as of 2014).

“The United States Space Surveillance Network detects, tracks, catalogs and identifies artificial objects orbiting Earth, e.g. active/inactive satellites, spent rocket bodies, or fragmentation debris. The system is the responsibility of the Joint Functional Component Command for Space, part of the United States Strategic Command (USSTRATCOM). Space surveillance accomplishes the following:

- Predict when and where a decaying space object will re-enter the Earth's atmosphere;
- Prevent a returning space object, which to radar looks like a missile, from triggering a false alarm in missile-attack warning sensors of the U.S. and other countries;
- Chart the present position of space objects and plot their anticipated orbital paths;
- Detect new man-made objects in space;
- Correctly map objects travelling in the Earth's orbit;
- Produce a running catalog of man-made space objects;
- Determine which country owns a re-entering space object;

- Inform NASA whether or not objects may interfere with satellites and International Space Station orbits.

The SPACETRACK program represents a worldwide Space Surveillance Network (SSN) of dedicated, collateral, and contributing electro-optical, passive radio frequency (RF) and radar sensors. The SSN is tasked to provide space object cataloging and identification, satellite attack warning, timely notification to U.S. forces of satellite fly-over, space treaty monitoring, and scientific and technical intelligence gathering. The continued increase in satellite and orbital debris populations, as well as the increasing diversity in launch trajectories, non-standard orbits, and geosynchronous altitudes, necessitates continued modernization of the SSN to meet existing and future requirements and ensure their cost-effective supportability.”

If these officers believe my accusations have no merit, then they will not be bothered by them.

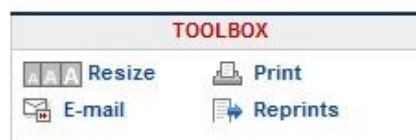

The CIA has plans to relocate the headquarters of its domestic division, which is responsible for operations and recruitment in the United States, from the CIA's Langley headquarters to Denver, a move designed to promote innovation, according to U.S. intelligence and law enforcement officials.

About \$20 million has been tentatively budgeted to relocate employees of the CIA's National Resources Division, officials said. A U.S. intelligence official said the planned move, confirmed by three other government officials, was being undertaken "for operational reasons."

A CIA spokesman declined to comment. Other current and former intelligence officials said the Denver relocation reflects the desire of CIA Director Porter J. Goss to develop new ways to operate under cover, including setting up more front corporations and working closer with established international firms.
