



Activities are being organized around the world among the millions of victims of Electronic Torture to inform the public that July 31 is "World Day Against Electronic Torture." For the first time ever

Professor Nils Melzer, UN Special Rapporteur on Torture, will present to the 75th UN General Assembly Session in October his report on "Cybertorture" which are Forms of Computerized Remote Electronic Torture against Illegally Targeted Individuals worldwide. This includes:

- Remote Electronic "Tagging" of Innocent Victims by Brutally Assaulting Them through their Bodies and into their Neurological Systems with Microwave Pulses and Radiofrequency Signals, using Directed-Energy Weapons and Directional Antennas, in order to Conduct Round-the-Clock Remote Electronic Surveillance over them **in the privacy of their own homes**. Often, these Illegal Forms of Electronic Surveillance --through the Bodies of innocent Victims--are conducted by Corrupt Law Enforcement Officers, Military and Intelligence Agencies, with Microwave Weapons, in a method called "**Remote Neural Monitoring**;"
- Criminal Forms of Electronic "**Mind Control**" Experimentation to Manipulate the victims' Bodily Functions, which are Usually Directed From The Brain, including Artificially Manipulating and Altering the Functions of all the Body Systems, such as Motor, Digestive, Neurological, Circulatory, Evacuations of Bladder and Bowel, etc.;
- Illegal Electronic Sending of **Subliminal Unwanted Messages** (Voices or Musical Themes) for Psychological "Entrainment" -- which are forms of "Brainwashing"-- by penetrating the victims' Auditory Cortex in the back of their head, right into their Brain, by means of "**Voice-to-Skull**" Technologies (patented), known as "**V2K**";
- Illegal Remote "**Mind Reading**" Experimentation which consists of Detecting Involuntary Movements of Vocal Cords Sub-vocally (patented), and other Advanced Ways. When the victim Is Not Speaking but Thinking in Silence, an A.I. Computer Figures Out what the victim is "Thinking About" by analyzing the victim's Involuntary Vocal Cord Movements, including the victim's very private Mental Prayers, etc.;
- And many other Dangerous Forms of Criminal and Illegal Experiments currently conducted over Large Masses of Defenseless Civilian Population, without the victims' **Informed Consent**--an essential Legal Requirement for Human Experimentation under the **U.S. Belmont Report**--and it also violates the **Nuremberg Code** which Forbids Abusive Human Experimentation. This constitutes a Total Violation of All Victims' Constitutional Rights, including the Human Rights and Fundamental Freedoms of U.S. Citizens and Residents, and Millions of Other Victims Worldwide.

These Atrocities also Violate the **Geneva Convention** and Its **Protocols**, which Forbid Using those **Weapons Of War**, Classified Worldwide as **Weapons Of Mass Destruction (WMDs)**, in **War Crimes** over Civilian Populations, especially when Not At War.

THE UNITED NATIONS CONSIDERS THE CURRENT ACTS OF "CYBERTORTURE" OVER CIVILIAN POPULATIONS WORLDWIDE AS "A CRIME AGAINST HUMANITY."

- In addition to the Electronic Torture forms explained, there is another type of Torture that is included in this program--which is the **Stalking** by either Single Individuals or Groups of Individuals in order to Deliberately **Harass** and **Intimidate** the Innocent Civilians who have been Targeted.
- This type of Stalking, also known as **Gang Stalking** or **Organized Stalking** is often done by **Bullying** the victims and **Mobbing** them in public, in shopping malls, at work, and sometimes they perform what is called "**Street Theater**," where a group of people has rehearsed in advance how to Harass and Intimidate an individual as though it was part of a Rehearsal, as a Play, or to **Intimidate** and **Terrorize**. These actions are carried out as a form of Psychological Torture or an effort to Intimidate victims when they try to Report or Redress these Human Rights Violations. This appears to be a form of **State or Domestic Terrorism**.
- The **Individual or Group Torturers** often performed by **Paid Operatives** or **Informants**, which are commonly hired by **Fusion Centers** in the United States, and many are employees of an FBI Unit called **InfraGard**, which has a **published salary scale**, and their own **logo as a National Security Unit** of the FBI. For a Payment, these Operatives accept to commit Human Rights Violations against their fellow Citizens and Residents in their Community.
- This happens all over the world, especially in the Northern Hemisphere where innocent civilians are being victimized. Their tactics are **invisibility** -- through invisible weapons, or "hiding in plain sight." These violations are being **investigated worldwide**, and the UN for the First Time is investigating these **Crimes Against Humanity**, which will be brought to its General Assembly Session in October as a report and draft resolution on **Cybertorture**.

We Appeal to Government Officials, Members of Law Enforcement and Legislators at State and Federal Levels, as well as the Inspector General at the Department of Justice, to Investigate and conduct Audits over the Operations of Fusion Centers, Intelligence, and Military Agencies, to determine why resources allocated to them to Combat Real Terrorism are being employed instead to Assault, Surveil, and Take Away the Human Rights and Fundamental Freedoms of Innocent Civilians, in total Violation of the Constitution of the United States of America.

We Demand that an Immediate Moratorium be placed on this Invisible War being Carried Out Against Innocent Americans, through Legislation by Congress, Enforcement by the President, and Insured by the Judiciary Immediately.
